Conditions for Demolition Permit Issued by the City of Hampton, GA

1. All land disturbance to be stabilized with vegetation upon completion of demolition.
2. No tree with DBH greater than 8" shall be removed without prior approval of the City of Hampton, GA
3. All demolition debris shall be hauled off site.
4. Dumpsters and/or temporary sanitary facilities shall not be located in the street or tree protection area or other right-of-way.
5. Additional erosion controls shall be installed as deemed necessary by the on-site inspector(s).
6. Any asbestos material shall be properly disposed of as per State of Georgia E.P.D. protocol.
7. Vermin and rodent extermination shall be provided as needed before demolition activities as to avoid nuisances to adjacent properties
8. Erosion control measures shall be adequate to protect saved trees on site, state waters, intermediate regional floodplain, drainage systems, required buffers, and adjacent property, including county or state right-of-way.
9. If applicable, all required buffers and floodplains shall be clearly demarcated using sediment barriers and/or tree protection fencing. All state water buffers and floodplains shall have a double row of type "C" silt fence along entire limits.
10. No trash, building debris, or construction waste will be buried inadvertently on any building site.
